- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名冊;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;

- 向本公司或H股證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監管機 關或政府部門或遵照其他法例、規則或法 規;及
- 證券持有人與其進行或擬進行交易的任何人 士或機構、例如彼等的銀行、律師、會計師 或股票經紀等。

# 4. 個人資料的保留
